- Detailed reason and attributes of the candidate's endorsement It is the responsibility of the candidates to conduct their campaigns in a professional manner, and without the solicitation of membership data from the National

 Administrator.



CCFCC Winnipeg Branch Annual General Meeting June 10th, 2015 @ 6pm Sysco Food Services

At this year's AGM the board is planning to put forth for membership vote a change to Article 5F of the Constitution, which defines the size and makeup of the Board of Director's.

Immediately following the AGM there will be an election meeting for all positions on the Board. Below are the duties for the Officers as outlined in the Constitution. The Branch encourages you to review these and consider running for a position. As well there are Board positions that are not as defined, however required to provide an advisory capacity and committee representation.

President: The President, (or in his/her absence the First Vice President, and in his/her absence the Second Vice President), shall preside at all meetings of the Association and Board of Directors and appoint all committees of the Association, unless ordered by the Association. He/She shall have the casting vote in the event of a tie on any question before the Board of Directors or in meetings of the Association and shall sign all warrants upon the Treasurer and in general, have a supervisory power over the affairs of the Association to see that it's rules and regulations are rigidly enforced.

Vice President: In the absence of the President, the First Vice President, (and in his/her absence the Second Vice President), shall preside at all meetings of the Association and the Board of Directors and at such meetings shall have the same power as the President. The Second Vice President shall be Chairperson of the Membership Committee.

Secretary: The Secretary shall keep accurate minutes of all proceedings of the Association and of the Board of Directors in a fair and impartial manner, and shall endorse and file all papers and documents pertaining to the transactions of the Association or its by-laws, all drafts and official documents, and shall file all communications of the Association or of the Board of Directors for future reference. In the absence of both the President and Vice Presidents from a meeting, the Secretary shall bring the meeting to order and a temporary Chairperson shall be appointed for the meeting. The Secretary should proofread, when possible, all the Recording Secretary's minutes for errors and omissions before they are transcribed for mailing.

Treasurer: It shall be the duty of the Treasurer to receive all monies belonging to the Association and to disburse the same under the direction of the Board of Directors by cheque or order signed by the President and attested by the Secretary. He/She shall hold in trust all securities, investments and other property, as well as the funds belonging to the Branch and shall transfer, exchange or deposit the same or any part thereof, when required by the Association to do so. The Treasurer shall keep a full and correct account of all monies received, expended and/or invested, and at each annual general meeting, produce the bank books together with a full report in writing of all receipts and disbursements with a detailed statement of the funds and the investments belonging to the Association and further to supply the same to the President, Board of Directors or Auditing committee whenever required by them to do so. The Treasurer shall be under bond in the manner and to the amount determined by the Board of Directors.

Committees: All committees shall be subject to the exercise of the supervising power of the Board of Directors. The Board of Directors shall appoint the Chairperson of the Committee.
